



Board of Directors Meeting

April 9, 2010

1. The second 2010 River Ridge Ranch (RRR) Board of Directors (BOD) meeting began at 7:15 p.m., March 24, 2010, at the home of Lisa Gross.

3. Opening Remarks: Pat Lisowski opened the meeting by welcoming board members and the addition of Deb Turland, Chairman of the Architectural Committee.

4. Old Business:

A. The minutes from the February 24th meeting were reviewed. Deb motioned to approve Ace second and the minutes were approved and signed. They will be posted on the website.

B. Copies of the Second Amendment and Restatement of Declaration of Covenants, Conditions and Restrictions of River Ridge Ranch were distributed for final review.

C. Resolution to Amend the Covenants was reviewed. Within the next few weeks Pat will sign, notarize, and file the document with Bell County.

D. Funding road maintenance. This is a long-term goal that we want to work on as a board. Next month Pat will get with the Bell County engineers to have the roads assessed. He will coordinate with John Fisher whose property is adjacent to River Ridge Ranch. There was discussion about two different philosophies in addressing the roads. One is that we just repair just those areas that need repaired versus a plan to resurface the entire RRR roads every 7 (or pre-determined) years. This action will be carried to the next meeting.

5. Reports:

A. VP, Operations (Ace).

(1). Lot 7 Section 1, Lawrence property. The variance was approved and paperwork completed.

(2). Roads. The pothole in the road in front of the Gillaine's was patched. If we have enough materials to patch we're going to get a bid on a big repair – estimated at \$5.00/ft.

(3). Oncor update. On April 1st the Public Utilities Commission will meet and there will be more information to follow; by law April 5th is the deadline. The group is asking for more monetary donations to cover legal fees. *Update: PUC Commissioners pick Route 207 and require use of monopoles on 4 or 5 miles of Route 207 closest to the Lampasas River. (E-mail sent to RRR landowners)*

B. VP, Administration (Ed). All correspondence to home and landowners will be prepared and signed by Ed.
